In relation to the inside information registered with the Spanish Securities Market Commission (*Comisión Nacional del Mercado de Valores – CNMV*) on April 11, 2024 (registration number 2193), relating to the repurchase program implemented by the Company, pursuant to the authorization granted by the annual shareholders meeting held on June 16, 2022, under item twenty-second of the agenda (the "**Repurchase Program**"), it is hereby announced that between 22 August and 23 August, 2024, the Company has carried out the following transactions under the Repurchase Program:

In addition to the above, the Company reports that, after the reported transaction, the Company has acquired a 100% of the maximum number of shares prescribed in the Repurchase Program (2,000,000 shares, representing approximately 0.44% of the Company's share capital). The shares have been acquired for a cash amount of EUR 3.741.788.29.

In this context, the Company announces that the Repurchase Program is terminated prior to its expiry.
